Pursuant to the faculties conferred to the Secretary of the Treasury under sections (i) and (h) of Article 3 of Reorganization Plan No. 3 of the Department of the Treasury from 1994, which authorizes the Secretary of the Treasury to establish regulations, and in accordance with Section 2.1 of Act No. 38-2017, as amended, known as the Uniform Administrative Procedures Act of the Government of Puerto Rico, this Notice is published for the enactment of the following regulations: **"REGULATION TO REPEAL REGULATIONS OF THE DEPARTMENT OF THE TREASURY THAT LACK USE OR RESULT OBSOLETE"**.
